The design must find solutions to the following architectural-technical and historic building related issues on the basis of the design programme to be made available by

the Contracting Entity:

- 1. Architectural, technical, and historic reconstruction of the significantly deteriorated building.
- 2. Reformation of the entire exhibition system, taking into consideration the reorganisation of the functions of the building, making available considerable spaces. Creating such spaces for the purpose of the placement of works of art, which allow the creation of an environment meeting the highest requirements of the protection of works of art.
- 3. Constructing a building on the site of the unimplemented wing in Hőgyes Endre Street, architectural "completion" of the building. Creating a unity of the old and new building parts, meeting the highest functional and aesthetic standards.
- 4. Connection between the building and its environment, urbanistic embedding.
- 5. Reconsideration of operational (building management) issues, ensuring environmentally conscious-and economic operation.

The direct objective of the procedure is to select the designer(s) suitable for solving the design task by comparing and ranking the submitted architectural designs, and to engage in preliminary discussions to clarify the professional conditions of the design assignment.

The Museum of Applied Arts wishes to enter into a design contract with the author(s) of the winning design for preparing the licensing plans of the building, with regard to Article 94(5) of Act CXIII of 2011 on Public Procurement.

- 1) Participation in the procedure is subject to the condition of purchasing the design contest documentation. A copy of the certificate of having purchased the documentation shall be attached to the **tender** in an envelop. The documentation may not be published or transferred to third persons.
- 2) Each participant in the design contest may file one design only.
- 3) The Contracting Entity grants an opportunity to visit the site on 21 May 2012. Meeting: Main entrance to the Museum of Applied Arts (if numerous persons express their interest, visitors will enter in groups at 10:30, 12:30 and 14:30).
- 4) Guidelines, official regulations, standards, and norms to be observed in the course of design: pieces of legislation applicable to and professional rules of architectural-engineering design, and the fact that the building of the Museum of Applied Arts is a protected historic building.
- 5) The participants may submit their questions concerning the design contest notice and the documentation to the address(es) specified in Section I.1) until 25 May 2012 via registered mail, fax, or e-mail. Responses shall be sent by the Contracting Entity by 6 June 2012.
- 6) Place and date of submitting the designs: designs may be submitted until 16 July 2012 24:00 via post only. The jury will exclude from the design contest without any consideration those designs which are submitted after the deadline or which violate the secrecy obligation required under Government Decree No. 305/2011 (XII. 23.). Designs shall be deemed by the Contracting Entity as submitted at the certified time they were sent by post.
- 7) Announcement of the results of the design contest: 10 August 2012, 10:00, at the following address: Museum of Applied Arts, 1091 Budapest, Üllői út 33-37, "Üvegcsarnok".
- 8) The jury announces the contest to be unsuccessful, if no design is found worthy of a prize or of being purchased, and may reduce the amount spent on prizes or (and) purchasing, if it finds the design contest to be of reduced value for utilisation purposes.

The ownership of awarded and purchased designs shall be transferred to the Contracting Entity, who may use such designs, or any part thereof, without any further remuneration and in line with copyright legislation.

Designs not awarded or purchased shall be returned by the Contracting Entity to the respective participant. Participants may prohibit the presentation of their designs in a statement made at the end of the description of their designs. In such cases and unless the participant made such a statement, participants may collect their designs after the announcement of the results at the address of the Contracting Entity (if they present the sending confirmation slip), after the designs were presented publicly.

9) After the procedure was announced successful by the jury, the Contracting Entity, in order to finalise the proposals and to prepare the designs for licensing, shall conduct a negotiated public procurement procedure without notice (Article 94(5) of the Public Procurement Act), to which it shall invite the winner(s) and awarded participant(s) of the contest upon the recommendation of the jury. The Contracting Entity indicates that a net sum of HUF 137,800,000 is expected to be available for the preparation of the licensing plans.

The Contracting Entity also indicates in relation to the negotiated procedure to be published without a notice that, under Article 55(1) of the Public Procurement Act, it shall determine minimum eligibility criteria concerning professional expertise and qualifications, and economic and financial situation in proportion to the significance of the design task (primarily regarding the references and the professionals required for the design work). Joint offers may be submitted and the capacities of other organisations may be used under Article 55 (4) to (6) of the Public Procurement Act in order to meet the eligibility criteria. For the purposes of the negotiated procedure to be published without a notice, the Contracting Entity shall apply the grounds for exclusion stipulated in Article 56(1) to (2) of the Public Procurement Act.

The deadline for preparing the licensed construction plan shall be the 115th day from the date of concluding the design contract.
