Dear visitor, welcome to the György Ráth Villa.

Please be informed that by entering the museum you accept the museum policy and visitor rules. The museum building is a state-owned listed building, so let us protect our valuable property together.

To ensure your visit is safe and enjoyable, please follow the rules below:

The building of the György Ráth Villa (H-1068 Budapest, Városligeti fasor 12) is open from Tuesday to Sunday from 10 am to 6.00 pm. The museum is closed on Mondays. Information about non-standard opening hours is available on our www.imm.hu website.

Visiting the museum and the current exhibitions is only permitted with a valid admission ticket purchased at the ticket desk or online at the museum's webshop, with the exception of private events. Discounted admission tickets can only be purchased by presenting the appropriate certificate for the discount at the ticket desk.

Please keep your tickets with you until the end of your visit.

Being a listed building, the museum is not wheelchair accessible.

VISITOR RULES

VISITING WITH SMALL CHILDREN: The museum happily welcomes young visitors, but for the safety of people and museum artefacts, the following rules must be observed: children below the age of 2 can only be taken into the exhibitions in the arms of a parent, or leading them by hand, or in front-facing baby carriers. Strollers are not allowed in the exhibitions. Guests arriving with strollers can use rooms not dedicated to exhibitions (ticket desk foyer, courtyard) for storing the strollers, but the museum cannot take responsibility for any valuables left unattended. Carrying children of any age on your shoulders or back is not permitted for security reasons.

Children under the age of 14 must be accompanied by a parent or caregiver when visiting the museum.

People visibly under the severe influence of alcohol or drugs, or scantily clad (absence of upper and/or lower garments) may not visit the museum – even if they have a valid admission ticket. No tickets can be redeemed or replaced with another ticket. Lost, destroyed or damaged admission tickets cannot be replaced.



The museum garden, exhibition halls, current exhibitions and events may be visited at your own risk.

Visitors may not drive into the museum by car or lorry, motorcycle, moped, scooter or any other means of passenger transport not listed herein. Visitors may leave their bicycles in the bicycle storage racks located in the courtyard of the museum free of charge, but we cannot take responsibility for any valuables left unattended.

Animals (except guide dogs), plants, weapons or anything that looks like a weapon, and other objects or substances posing a risk to human life, physical safety and health are not allowed in the museum. Child scooters, roller skates, skateboards, etc. are only allowed if they can be placed in the cloakroom.

It is forbidden to bring into the exhibitions food and drink or objects of a size that might disturb other visitors or block escape routes. It is strictly forbidden to eat and drink in the museum and the exhibition halls. It is forbidden to sit on the windowsill in the exhibition area, and to use the stairs for unintended purposes.

Visitors shall use the rooms and the garden of the György Ráth Villa for their intended purposes, look after the environment, and protect and handle the tools and equipment in the building and in the garden as well as the building and the garden itself according to rules and regulations.

It is forbidden to make too much noise anywhere in the museum, disturb the enjoyment of other visitors, or do anything that is not appropriate for a museum. Please switch your mobile phones to silent mode. Please keep a distance of at least 30 cm from the artworks.

Smoking is prohibited throughout the entire area of the György Ráth Villa. Smoking is allowed only in the designated areas.

Please be aware that we operate a closed circuit television system throughout the entire György Ráth Villa, and store the recordings for the period specified by law in accordance with our Data Protection Notice displayed in the museum and which can be downloaded from the museum's website: http://www.imm.hu/files/inlineattachments/kozerdeku/IMM_Adatkezelesi_tajekoztato_2018_0523.pdf.

In the case of any extraordinary event (e.g. natural disaster, fire, bomb threat, etc.), visitors shall closely follow the instructions from the museum staff, and act in accordance with the requirements laid down in the evacuation plan of the building.

We cannot take responsibility for any valuables left unattended in the museum.

Action taken by the museum staff (museum guards, security guards, curators) is binding for visitors.

Everybody shall make a reasonable effort to protect and avoid any risk to their own life and the lives of others, their physical safety, the property of the museum and others, and the building, furniture and equipment of the museum.

CLOAKROOM

Use of the cloakroom is obligatory and free of charge for all visitors. The museum is not responsible for anything left in the cloakroom.

Any packages, all backpacks, rucksacks, umbrellas and bags which have a size greater than 30×40×20 cm must be left in the cloakroom. For security reasons, visitors may not enter the exhibition halls with a wet coat in their hand or across their arms, or wearing a winter coat.

PHOTOGRAPHY AND VIDEO

Taking photographs in the museum for personal use only is permitted, but without using a flash, tripod or selfie stick. Photographs taken in the museum may not be used for purposes other than your own private and non-commercial use (e.g. publication). Video and audio recordings are not allowed throughout the György Ráth Villa and its exhibition halls. (Wedding photography is permitted in return for a separate fee by prior agreement.) Under no circumstances may visitors taking photos according to these rules disturb the other visitors.

CLOSING TIME

Visitors are kindly asked to leave the exhibition halls 10 minutes before the museum building closes so they have sufficient time to check out of the cloakroom.

Visitors who do not comply with the museum's policy may, after a warning, be banned from the building temporarily or permanently, or subject to official action. Any person breaching the museum's policy (or the person responsible for such person) shall be held liable for damages resulting from such breach. If the policy breach also breaks the law, the person breaching the policy (or the person responsible for such person) shall be liable under law and be subject to any legal sanctions.
